1. Welcome and Check-in: Meeting called to order at 6:05pm.

5 a). Executive Director Report - Khaled

- Regarding the move to 19 Main St: We have made an official announcement about signing the lease. There are two memos (one to staff, one to the general community) on Facebook, ACO website, and Twitter. This will be in the newsletter
- ACO funders have been informed of the move.
- Management team visited the new site today. By the end of the month everyone will have had a chance to visit 19 Main St.
- General timeline: contractors working for 3 to 4 weeks, should be done by end of the month or November.
- Other infrastructures: IT, phone, etc. will be fully up and running by December
- This should enhance ACO's image in a professional way. Our funders have wanted us to move in this direction. Programs should flow well in the new space.
- We can use the office furniture that has been left behind by the old tenants (room dividers, desks, etc.)
- Some members are concerned about transportation to the new site. Staff have mapped out how to get there by bus. This new location will open the ACO up to other communities such as Sandy Hill.

- Laura: we should take a picture of the old ACO on Bank St. to add to the history
- Kevin: Let's make it a volunteer member's project

5 b). Update on legal case

- A call from our lawyer: pre-trial hearing date pushed to October 2014, they will let Khaled know if there is anything new.

5 c). HR update

- ACO has three new hires and is now fully staffed. We will need to re-do the org chart.
- TLR hired JP Bergeron last Tue. Sept 2, 2014. He has great energy and experience working for le BRAS.
- Eno was hired to replace Fred as Women's Community Developer and is part of the community as they openly identify as a PLHIV.
- Derek Cassidy (a former Toolshed volunteer) was hired for Men's Outreach.
- In addition to the three new staff, ACO has a placement student, named Jason who is a mature Carleton University student working 4 days/wk at ACO and TLR
- AIDS Walk: this Saturday at Schneider Plaza at 2pm (Bank and Laurier), festivities will start at noon and wrap up at 3pm.

6. Vacant Board seat

- Kevin Hatt: with Greg's resignation, we have Sabrina Fabien from our reserve list who has met with the Nomination Committee. She has business training and organized fundraisers. She is also openly part of the trans community.
- Motion to make Sabrina Fabien a member of the ACO Board of Directors: Kevin Hatt; Seconded Jean. All in favour.

7. Finance Committee Report

- Khaled: Summary budget: a \$36,000 deposit for rent, so rent is over budget temporarily.
- Contracts: Adobe Consulting Services has been retained to provide the facilitation of our strategic planning processes
- Resources: legal fee to Caza Saikaley; we will readjust.
- Legal: money we've paid to Carters.
- Advances: monetary advances (catering, travel, etc).
