 - HR Update:

 - Rob Alexander's position was posted for a 6 month contract, interviews begun today and the hiring process should be complete by the end of next week
 - Two peer positions (6 weeks) for Totally Outright were filled using the funding from the Community Foundation of Ottawa

 - Anniversary / Book Proposal
 - o The Book Committee has met 5 to 6 times in the past few months
 - The Board members on the Book Committee are Richard, Jean, Kevin Hatt, and Gord
 - o A company, Skylarc Pictures has made a pitch to the Committee
 - Skylarc Picture referred the Committee to Watersource Creative since they are a publishing company
 - James from Watersource came to Ottawa from Toronto to meet with the Committee
 - The Committee is thinking of having a coffee table book of the HIV/AIDS
 Movement in Ottawa over the last 30 years
 - Watersource and Skylarc presented a proposal for a hard copy and digital book to the Committee, the digital book would have its own website so that it can generate funds on an ongoing basis
 - Budget considerations: Book; launch of the Strategic Plan by Beth of Adobe Consulting; and the cost of the September 19, 2015 event
 - The event needs to be a classy affair since the perception of ACO is starting to change – so we need to invest in a decent venue and provide

- people with a good meal and board and staff members don't have to serve
- Khaled needs to know what the budgetary constraints are and the maximum that he can spend on everything related to the 30th Anniversary
- Soyini suggested that we look into how much other companies would charge for the book to make sure that we are getting the best deal
- Kevin Hall pointed out that we need to be able to have a way to register for the event and estimate the cost of a plate/per person
- Khaled is expecting anywhere from 100 to 200 people will attend the event
- o Kevin Hall and Lauren will look into the cost of City Hall
- Motion to approve \$50,000 for Khaled to start negotiations for the Anniversary celebration event, the development of the book, the launch of the Strategic Plan, and the actual event with the expectation that Khaled will come back to the Board in the future when he needs more money
