#### Quorum

#### 1. Welcome and call to order

Jason Brophy, Chair of the Board of Directors, welcomed ACO members to the 2020 virtual Annual General Meeting and called the meeting to order at 6:05 PM.

#### 2. Approval of the agenda

MOVED by Laura Hoover-Jean and SECONDED by Mike Laframboise that the agenda be approved as presented. **Motion CARRIED**.

### 3. Traditional welcome and opening ceremony

Mike, Austin, Jimmy, and Rosie guided members through the traditional welcome and opening ceremony and smudge, and acknowledged the Algonquin people whose land we gathered upon for this meeting

### 4. Hope and remembrance ceremony

Haoua acknowledge those people from the HIV community who passed away in the past year and lit virtual candles in remembrance, following which a minute of silence was observed.

# 5. Presentation and adoption of the Audited Financial Statement and Report

Jason introduced the ACO's Auditor, Marc Brazeau of Marcil-Lavallée) and invited him to present the Audited Financial Statement/Report for Fiscal Year ended March 31, 2020 (circulated to members with the official notice of this meeting). Marc reviewed the audit's highlights and significant findings noting that the Audit Team found no anomalies or specific areas of concern.

MOVED by Jeff Potts and SECONDED by Ali Sougou that the Audited Financial Statement/Report for Fiscal Year ended March 31, 2020 be adopted as presented. **Motion CARRIED**.

# 6. Appointment of Auditor for Fiscal Year ending March 31, 2021

MOVED by Rick Philips and SECONDED by David Stinson that ACO members approve the appointment of the Audit firm, Marcil Lavallée, to undertake the official audit of the ACO's financial records for Fiscal Year ending March 31, 2021. **Motion CARRIED**.

# 7. Annual Report

Peter Szanto, the ACO's Volunteer Coordinator, presented the 2020 Annual Report noting that, due to the ongoing COVID-19 pandemic, publication of the Report was undertaken virtually, and paper-based dissemination will be limited. # 8. Messages from the Executive Director and the Chair of the Board of Directors

Khaled Salam, the ACO's Executive Director reviewed the highlights of his message contained (in detail) in the Annual Report. He also noted that the pandemic has revealed serious issues related to racism and racial disparities that the ACO will strive to address in the coming year.
